

**COASTAL ZONE MANAGEMENT & RESTORATION
ADVISORY COMMITTEE MINUTES
OF
December 5, 2023**

1. Chairman Mickey Thomas called the regular meeting of the Coastal Zone Management & Restoration Advisory Committee to order at 5:00p.m. Tuesday, December 5, 2023, in the Council Meeting Room, 2nd Floor, Government Tower. Mr. Thomas led the Invocation and the Pledge of Allegiance.
2. Upon roll call, present were Ernie Babin, Bobby Barthel, Tony Antill, Jan Rogers, Jordan Lirette and Mickey Thomas. Absent: Jeff DeBlieux and Barry Soudelier. Also present was Mr. Mart Black, Director of the Terrebonne Parish Office of Coastal Restoration and Preservation.
3. Chairman Thomas welcome two new members to the Coastal Zone Management & Restoration Advisory Committee Mr. Tony Antill and Mr. Jordon Lirette.
4. Mr. Rogers moved, seconded by Mr. Barthel: "THAT the Coastal Zone Management & Restoration Advisory Committee **accepts** the minutes for the meeting of Nov. 7, 2023." *NO OPPOSITON, MOTION CARRIED, CHAIRMAN DECLARED MOTION ADOPTED.*
5. New Business:

Local Concern Applications: -

- The Chairman called to order the local concern application for **Lynn Duplantis**; Proposed to Clear out only the brush for a Mobile Home Pad (Residential) with a small driveway. 199 Klondyke Road, Bourg, LA; Terrebonne Parish, LA P20230275 – Public Notices ends – October 16, 2023.

Mr. Black reviewed the application with the Committee and after working on the WVA with the state there is no measurable impact (0.001 ac.) so no mitigation is required. The Application will be issued as a LCUP. Mr. Black recommended approval.

- The Chairman called to order the local concern application for **Low Land Construction**; Proposed excavate borrow pit for local levee; Section 30, T18S-R19E; Terrebonne Parish. **P20230924.**

Mr. Black reviewed the application with the Committee and stated there was no wetland impact. The Application will be issued as a LCUP with Conditions: Must stay within Upland Section as shown on the JD from Corps of Engineers – MVN-2023-00649-SK, Must stay within 50ft of adjacent property line, Must keep road free of mud and dirt within ½ mile of access road, and follow all state and local signing requirements. Mr. Black recommended approval.
