**“REVISED NOTICE TO THE PUBLIC”**

The Terrebonne Parish Council will **NOT** hold Committee Meetings on Monday, March 23, 2020 in order to limit the amount of meetings. All significant items are being placed on the Regular Council Meeting on Wednesday, March 25, 2020.

Based upon declaration Of Public Health Emergency, La RS 29:766, by the Governor of the State of Louisiana, John Bel Edwards pursuant to Proclamations 27-JBE-2020 and 30-JBE-2020, the Parish President for Terrebonne Parish, Gordon E. Dove, has declared a state of Emergency within Terrebonne Parish. Within the sole Powers granted to him pursuant to La RS 29:727, Parish President Dove has ordered the following protocol for any person attending the Public Council Meeting set at TPCG Council Meeting room on Wednesday, March 25, 2020 beginning at 6:00 p.m. ANY PERSON WHO REFUSES TO COMPLY WITH THE PROTOCOL ESTABLISHED WILL BE DENIED ADMISSION. THE PURPOSE OF THE PROTOCOL IS TO MINIMIZE THE RISKS AND THREAT OF THE PANDEMIC CORONAVIRUS -19.

All attendees will be required to fill out the following questionnaire prior to entering the building:

If you answer, “yes,” to any of the questions, your access to the building may be restricted.

- Have you had any recent foreign travel? If yes, where?
- Have you experienced fever and symptoms of lower respiratory illness (e.g., cough and/or shortness of breath) in the last 14 days?
- Have you been in the vicinity of a person with possible COVID-19 infection?
- Has a member of your family member been in close contact with or in the vicinity of a person with possible COVID-19 infection?
- Have you been in close contact with a laboratory-confirmed COVID-19 patient?

Individuals will also be subject to a laser temperature check prior to entering the meeting room.

Individuals “Wishing to Address the Council” will have to fill out a speaker card prior to entering the building, subject to the aforementioned access requirements and the item must be on the agenda.

The Council is working on having this meeting live-streamed for the public to view. We will keep the public informed if the Wednesday, March 25, 2020 Council Meeting has to be handled in a different manner or cancelled due to the health, safety & welfare of individuals attending the meeting.
