

## NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with the agency and are willing to give of their time and talents. At the January 9, 2008 meeting of the Parish Council, individuals are scheduled to be appointed to the following agencies:

- **Coastal Zone Management Advisory Council:** (one expired term representing the real estate industry) Interested parties should be Terrebonne Parish residents and should have an interest and knowledge of the coastal issues.
- **Recreation District No. 1 Board:** (one expired term) Interested parties must residents of Recreation District No. 1 and should have an interest and knowledge of the recreation programs in the Gray/Schriever area).
- **Bayou Blue Fire Protection District Board:** (three expired terms) Interested parties must be property-owning residents of the district and should be interested in the administration of local fire protection services.
- **Bayou Cane Fire Protection District Board:** (three expired terms) Interested parties must be property-owning residents of the district and should be interested in the administration of local fire protection services.
- **Coteau Fire Protection District Board:** (Three expired terms) Interested parties must be property-owning residents of the district and should be interested in the administration of local fire protection services.
- **Fire Protection District No. 4 Board:** (one expired term) Interested parties must be property-owning residents of the district (Grand Caillou) and should be interested in the administration of local fire protection services.
- **Fire Protection District No. 8 Board:** (expired terms) Interested parties must be property-owning residents of the district (Gibson, Donner & Chacahoula) and should be interested in the administration of local fire protection services.
- **Village East Fire Protection District Board:** (Two expired terms) Interested parties must be property-owning residents of the district and should be interested in the administration of local fire protection services.
- **South Central Human Services Authority Board:** (One vacancy) Interested parties must be interested in the newly formed state organization created to address mental health needs in the multi-parish district and should represent mental health services.
- **Houma Area Visitors and Convention Bureau:** (One vacancy) Interested parties must be Terrebonne Parish residents and be nominated by a local civic or community organization interested in promoting Terrebonne Parish.
- **Houma Municipal Fire and Police Civil Service Board:** (One vacancy) Interested parties must be residents of the City of Houma and somewhat familiar with civil services regulations.
