The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. The Parish Council will consider at its **NOVEMBER 16, 2022, Regular Session** meeting the following vacancies and appointments:

**RECREATION DISTRICT NO. 1 BOARD:** One (1) expiring term on 12-03-22.

**RECREATION DISTRICT NO. 3A BOARD:** One (1) expired term.

**RECREATION DISTRICT NO. 5 BOARD:** One (1) expiring term on 12-26-22.

**RECREATION DISTRICT NO. 6 BOARD:** One (1) expired term.

**RECREATION DISTRICT NO. 10 BOARD:** One (1) expiring term on 12-18-22.

**BAYOU BLUE FIRE PROTECTION DISTRICT BOARD:** One (1) expired term.

**COTEAU FIRE PROTECTION DISTRICT BOARD:** One (1) expired term.

**FIRE PROTECTION DISTRICT NO. 8 BOARD:** One (1) expired term.

**CHILDREN AND YOUTH SERVICES BOARD:** Six expiring terms, three (3) on 11-05-22 and three (3) on 11-16-22 (Each representing one of the following: Social Services, Terrebonne Parish Juvenile Justice, Education and Terrebonne Parish District Attorney), one (1) vacancy (representing Bayou Area Children Foundation) due to a resignation and five (5) expired terms (One representing each of the following: City Court, Office of Juvenile Justice, Gulf Coast Teaching and Family Services, Terrebonne Parish Sheriff’s Office and Houma Police Department representative).

**TERREBONNE PARISH TREE BOARD:** Three (3) vacancies due to resignations.

**COASTAL ZONE MANAGEMENT:** One (1) expired term on 10-31-22.

**DOWNTOWN DEVELOPMENT:** Four (4) expiring terms on 11-01-22. (One representing each of the following: Downtown Merchants, Convention and Visitors Bureau, EDAB/Council and Arts and Humanities)

**PLANNING AND ZONING COMMISSION:** One (1) expiring term on 11-30-22 (Council Representative – African American)

**MUNICIPAL CIVIL SERVICE BOARD:** Two (2) expiring terms on 11-29-22.

**HOUMA AREA CONVENTION AND VISITORS BUREAU:** Two (2) expiring terms on 12-31-22.

**HOUMA – TERREBONNE PUBLIC TRUST FINANCE:** Three (3) expiring terms, one (1) on 12-18-22 and two (2) on 12-26-22.

**PORT COMMISSION:** Two (2) expiring terms on 12-31-22. (Each representing the Parish President)

**911 COMMUNICATIONS DISTRICT:** Four (4) expiring terms on 12-31-22.

Interested individuals wishing to be appointed to a Recreation Board must be a resident of the Recreation District and be willing to attend regularly scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
