The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. The Parish Council will consider at its **December 16, 2020 Regular Session** meeting the following vacancies and appointments:

**HOUMA PUBLIC FINANCE TRUST:** Two expiring terms on 12-26-20. (Council Appointment)

**HOUMA AREA CONVENTION AND VISITORS BUREAU:** One unexpired term on 12-31-22. (Representing a Civic Non-Profit Organization)

**RECREATION DISTRICT NO. 7:** One expiring term on 01-06-21.

**FIRE PROTECTION DISTRICT NO. 9:** Two expiring terms on 01-01-21.

**FIRE PROTECTION DISTRICT NO. 10:** Two expiring terms on 01-01-21.

**FIRE PROTECTION DISTRICT NO. 8:** Two expiring terms on 01-01-21.

**BAYOU BLUE FIRE PROTECTION:** Two expiring terms on 01-01-21.
