

## NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (\*11/5/14)
- **Houma Downtown Development Corporation:** (One expiring term) Interested individuals must be citizens of Terrebonne Parish and interested in the future development of downtown Houma. (\*11/5/14)
- **Recreation District No. 10 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (\*11/5/14)
- **Library Board of Control:** (Three vacancies) Interested individuals must be citizens of Terrebonne Parish and must be willing to perform all duties and powers with respect to the parish public library system as enumerated by state law. (\*11/5/14)
- **Houma-Terrebonne Downtown Development Commission:** (Three expiring terms) One representing the Historical Society; One representing the Parish Council, and one representing the Garden Clubs (11/5/14)
- **Houma Area Convention and Visitors Bureau:** (One expiring term) Qualified individuals should be interested in the promotion of Terrebonne Parish to outside vendors. (11/5/14)
- **Terrebonne Economic Development Authority:** (One vacancy) Interested individuals must be a resident of Terrebonne Parish and either a proprietor, partner or officer of a business within Terrebonne Parish. (11/5/14)
- **Recreation District No. 3A Board:** (One expiring term) Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meeting to discuss and take action on matters pertaining to recreational facilities and activities therein. (11/19/14)
- **Municipal Fire and Police Civil Service Board:** (One expiring term) Council nomination. (11/19/14)
