The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (\*7/22/15)
- **Recreation District No. 11 Board:** (One expired term) Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (\*7/22/15)
- Recreation District No. 10 Board: (One vacancy due to a resignation) Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (\*7/22/15)
- Terrebonne General Medical Center Hospital Services District No. 1 Board: (Three expiring terms) One representing a Civic Organization (nominated by a bona fide local civic or community organization), one representing the Medical Society (3 nominees from the Terrebonne Medical Society), and one representing the Terrebonne Bar Association (3 nominees from the Terrebonne Parish Bar Association).(\*7/22/15)
- Terrebonne Economic Development Authority (TEDA newly reseated Board as of 8/1/15, Act. 191): (nine vacancies) Interested individuals must be a citizen of the United States, a qualified voter residing within the boundaries of the authority, and either a proprietor, partner, or officer of a business located within the boundaries of the authority. The board shall be composed as follows:
- One Member appointed by the Terrebonne Parish President.
- Two Members, both of whom are Black or African American, appointed by the governing authority of Terrebonne Parish.
- Three Members appointed by the governing board of South Central Industrial Association, confirmed by the governing authority of Terrebonne Parish.
- Three Members appointed by the governing board of the Houma-Terrebonne Chamber of Commerce, confirmed by the governing authority of Terrebonne Parish. (\*08/12/15)
