

NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. *At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

Terrebonne Parish Youth Advisory Council: Two representatives from Covenant Christian; 1 Alternate from south of the Intracoastal. Members shall be residents of Terrebonne Parish, enrolled in an institution of education in Terrebonne Parish and shall be at least 13 years old and not older than eighteen years old or a high school senior. *(12/19/18)

Coastal Zone Management & Coastal Restoration Advisory Committee: One vacancy to fill unexpired term, representing fishing. *(12/19/18)

Downtown Development Corporation: One expired term nominated by the Downtown Merchants. *(12/19/18)

Houma Area Convention & Visitors' Bureau: One vacancy to fill unexpired term, nominated by a Civic Organization. *(12/19/18)

Houma-Terrebonne Finance Trust: Two expiring terms on 12/26/18 Houma-Terrebonne Public Trust Finance. Interested citizens should be a resident of the parish and interested in overseeing a financial program for the parish. *(12/19/18)

Terrebonne Parish Port Commission: Two expiring terms on 12/31/18. One applicant nominated by SCIA and one by the Chamber of Commerce. Registered voter of Terrebonne Parish and should be familiar or interested with the management of the Terrebonne Parish Port. *(12/19/18)

Terrebonne Parish Communications District Board: Four expiring terms on 12/31/18. One member representing each of the following: The Fire Chief's Association, the Houma Police Department, South Terrebonne (outside USD City Limits) and Medical Services. *(12/19/18)

Recreation District No. 5 Board: One vacancy to fill an unexpired term. *(12/19/18)

(Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities.)

Bayou Blue Fire Protection District: Two (2) expiring terms. *(12/19/18)
