The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

**Bayou Blue Fire Protection District:** One expired term. \*(1/15/20)

**Bayou Cane Fire Protection District:** One expired term. \*(1/15/20)

(FIRE DISTRICTS: R.S. 40 – 1496.D.(1) Each member of the board shall be a resident property taxpayer of the district.)

**Terrebonne Parish Tree Board:** Three vacancies. \*(1/15/20) (The Board’s responsibility is to study, investigate, counsel and develop and/or update annually, and administer a written plan for the care, preservation, pruning, planting, replanting, removal or disposition of trees and shrubs in parks, within public rights-of-way along streets and in other public areas.)

**Recreation District No. 3A:** One expiring term. Interested individuals must be a resident of the Recreation District and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. \*(1/15/20)

**South Central Human Service Authority:** One expiring term. Interested individuals must be residents of Terrebonne Parish and have past experience in the mental health care profession. Meetings are held monthly in various areas of a six-parish region. \*(1/15/20)

**Recreation District No. 7:** One expiring term. \*(1/15/20)

**Fire Protection District No. 10:** Three expiring terms. \*(1/15/20)

**Fire Protection District No. 4:** Three expiring terms. \*(1/15/20)

**Fire Protection District No. 8:** Three expiring terms. \*(1/15/20)

**Coteau Fire Protection:** Three expiring terms. \*(1/15/20)

**Schriever Fire Protection District:** Two expiring terms. \*(1/15/20)
