The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. \*At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

**Fire District No. 10 Board:** One vacancy due to resignation. (Interested individuals must be resident property taxpayers of the Fire Districts they are applying for and interested in the administration of fire protection services in the area. \*(8/10/16)

**Fire District No. 5 Board:** One unexpired term. (Interested individuals must be resident property taxpayers of the Fire Districts they are applying for and interested in the administration of fire protection services in the area. \*(8/24/16)

**Fire District No. 8 Board:** One unexpired term. (Interested individuals must be resident property taxpayers of the Fire Districts they are applying for and interested in the administration of fire protection services in the area. \*(8/24/16)

**Houma Board of Adjustments:** Two permanent positions and one Alternate Member’s terms expiring terms on 9/1/16. Interested individuals must be landowners and qualified voters of the urban planning district of the Parish. \*(8/24/16)

**Terrebonne Economic Development Authority (TEDA):** Four expiring terms on 9/9/16. One appointed by the Parish President. One appointed by the Chamber of Commerce. One Black or African American appointed by the Council and one nominated by SCIA. Z \*(8/24/16)

**Recreation District No. 2,3:** One expiring term on 9/10/16. . Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. \*(8/24/16)

**Recreation District No. 1:** Two expiring terms on 9/12/16. . Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. \*(8/24/16)

**Airport Commission:** One expiring term on 9/14/16. Interested individuals should be citizens and residents of Terrebonne Parish and should be interested and familiar with the management of the Houma-Terrebonne Airport \*(8/24/16)

**Veteran’s District:** Three expiring terms on 9/17/16. One representing the South of the Intracoastal (Parish President’s appointment), Two representing veterans organizations in Terrebonne Parish. \*(8/24/16)
