At the request of Mr. C. Harding, Director of Juvenile Justice, Joeseph Harris Jr. explained that he has a partnership with the District Attorney Joseph Waitz and Children and Youth Services. He stated this partnership helps divert juveniles from incarceration through assessments in conjunction with the SPARC program then noted that public resources and reports can be provided. He then noted that the Children and Youth Services Planning Board will monitor and report on this and other programs impacting juvenile citizens.

Mr. C. K. Champagne noted his experience with the program then shared his support for the resolution and the program's operation.

At the Chairman's inquiring, Mr. Harris noted that local judges can also provide awareness of the program to juveniles as well as provide referrals. (*RESOLUTION ADOPTED AFTER DISCUSSION)

RESOLUTION NO. 24-346

A resolution authorizing the Parish President to execute a new agreement between the Parish and Terrebonne Parish District Attorney's Office Juvenile Services for the Single Point Assessment and Resource Center Operation (SPARC).

WHEREAS, Article VII, Section 14 of the Louisiana Constitution further provides that "For a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual"; and,

WHEREAS, Title 46, Chapter 22, Part III of the Louisiana Revised Statutes authorized the governing authority of Terrebonne Parish, upon the enactment of appropriate resolutions, to create a children and youth planning board in Terrebonne Parish to provide for the preparation of a comprehensive plan for the development, implementation, and operation of services for children and youth in the parish;

WHEREAS, Title 46, Chapter 22, Part III of the Louisiana Revised Statutes also authorized the Terrebonne Parish governing authority to establish an advisory board which would report to a youth services planning board;

WHEREAS, as a result of the efforts and upon recommendation of the Single Point Assessment and Resource Center ("SPARC") Advisory Committee, Terrebonne Parish District

Attorney's Office Juvenile Services has requested funding from the TPCG in order to maintain the operation of the Single Point Assessment and Resource Center ("SPARC") in Terrebonne Parish, with the goals of providing comprehensive assessments for youth and families to facilitate referrals to appropriate resources and community services, maintaining a system designed to outline intervention needs and plans and monitor services as needed, and serving as a source of information to the juvenile justice system and children's policy makers; and

WHEREAS, TPCG has agreed to assist the Terrebonne Parish District Attorney's Office Juvenile Services with the SPARC program by providing Terrebonne Parish District Attorney's Office Juvenile Services with funds in an amount not to exceed \$250,000 per year of operation of the SPARC program pursuant to the attached agreement, with an option to renew funding for an additional term, in consideration for the services SPARC provides to the youth of Terrebonne Parish; and

WHEREAS, TPCG finds that entering into a new Cooperative Endeavor Agreement with Terrebonne Parish District Attorney Office Juvenile Services for the maintenance of SPARC operations in Terrebonne Parish shall further the Parish's goals of providing for youth services, and that same will benefit the citizens of Terrebonne Parish by establishing a single point of entry for youth and family resources offered within Terrebonne Parish; and

WHEREAS, TPCG finds that any expenditure or transfer of public funds according to the terms of this cooperative endeavor, taken as a whole, is not gratuitous, and that it has a demonstrable, objective, and reasonable expectation of receiving at least equivalent value in exchange for the expenditure or transfer of its public funds; and

NOW THEREFORE BE IT RESOLVED, by the Terrebonne Parish Council, to authorize and execute an agreement between the Parish and the Terrebonne Parish District Attorney Office Juvenile Services for the Single Point Assessment and Resource center operation (SPARC), and the form of the agreement shall be approved by the Parish Attorney.

If its charter permits, each of them also shall have the right to powers and functions granted to other local governmental subdivisions." And

WHEREAS, LSA-Const. Art. 6, §17, entitled "Land Use; Zoning; Historic Preservation states in its pertinent part that "Subject to uniform procedures established by law, a local governmental subdivision may (1) adopt regulations for land use, zoning, and historic preservation, which authority is declared to be a public purpose;" and

WHEREAS, Sec. 1-05 of The Home Rule Charter for a Consolidated Government for Terrebonne Parish states in its pertinent part that "The parish government shall have and exercise such other powers, rights, privileges, immunities, authority and functions not inconsistent with this charter as may be conferred on or granted to a local governmental subdivision by the constitution and general laws of the state, and more specifically, the parish government shall have and it hereby granted the right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs, not denied by this charter, or by general law, or inconsistent with the constitution." And

WHEREAS, Section 1-06 of the Home Rule Charter for Terrebonne Parish Consolidated Government (TPCG) provides that the Parish Government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and

preserve the general welfare, safety, health, peace and good order of the parish, including but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary requisite or proper for the management of parish affairs, and all other subject matters without exception, subject only to the limitation that the same shall not be inconsistent with the Constitution or expressly denied by general law applicable to the parish; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code; and

WHEREAS, TPCG wishes to amend Sec. 28-76 of the Terrebonne Parish Code to include campgrounds under prohibited uses within the Supplementary Major Corridor Overlay District.

SECTION II

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that the following sections of the Code of Ordinances of Terrebonne Parish at Article IV, Section 28-76 shall be and are hereby adopted, with strike through to show deletions and underline to show additions:

Sec. 28-76. Supplementary Major Corridor Overlay District

- (2) Permitted uses. The permitted uses, prohibited uses and conditional uses in the Major Corridor Overlay District shall be in accordance with the uses permitted in the base zoning districts as listed in the individual district regulations of this zoning ordinance, with the following exceptions or stipulations:
- a. In the overlay district, nightclubs, bars, lounges, taverns and any other use that generates more than fifty (50) percent of its revenue through the sale of alcohol may not locate within one thousand (1,000) feet of any school, church, recreation area or playground, or any residentially zoned district, as measured from the front property line of the business along the highway corridor in any direction.

b. In the overlay district, campgrounds shall be prohibited.

SECTION III

WHEREAS, Sec. 1 - 05 of The Home Rule Charter for a Consolidated Government for Terrebonne Parish states in its pertinent part that "The parish government shall have and exercise such other powers, rights, privileges, immunities, authority and functions not inconsistent with this charter as may be conferred on or granted to a local governmental subdivision by the constitution and general laws of the state, and more specifically, the parish government shall have and is hereby granted the right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs, not denied by this charter, or by general law, or inconsistent with the constitution."

WHEREAS, Section 1-06 of the Home Rule Charter for the Parish of Terrebonne provides that the parish government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including, but not by way of limitation, the right, power and authority to pass ordinances on all subject matter necessary, requisite or proper for the management of the parish affairs, and all other subject matter without exception, subject only to the limitations that the same shall not be inconsistent with the Constitution or expressly denied by the general law applicable to the parish; and

WHEREAS, LSA-Const. WHEREAS, camping in public areas creates a danger to the safety and welfare of residents of Terrebonne Parish;

WHEREAS, the Terrebonne Parish Consolidated Government wishes to ban camping in public areas;

SECTION I

NOW, THEREFORE BE IT ORDAINED by the Terrebonne Parish Council that Section 19-7 of the Parish Code of ordinances shall be and is hereby be enacted to read:

Sec. 19-7 – Camping in a public area prohibited.

(a) Definitions. As used in this section, the following terms shall have the following meanings:

Camp means the use of a public area for living accommodation purposes for an extended period of time including:

- (1) Storing personal belongings;
- (2) Making a camp fire;
- (3) Using a tent or shelter or other structure for a living accommodation;
- (4) Carrying on cooking activities; or
- (5) Digging or earth breaking activities.

Public area means any and all streets, road rights of way, the area under a highway overpass, sidewalks, boulevards, alleys, parking lots, or other public ways and any and all public parks, squares, spaces, grounds and buildings.

- (b)It shall be unlawful for any person to camp in a public area that is not designated as a campground.
- (c)Unless a police officer determines that there is an imminent health or safety threat, a police officer shall, before citing a person for a first offense violation of this section, make a reasonable effort to:
 - (1) Advise the person of a lawful alternative place to camp;
 - (2) Advise the person of the location of a shelter or housing; and
 - (3) Contact, if reasonable and appropriate, a parish designee who has the authority to offer to transport the person or provide the person with services.
- (d)This section does not apply to a person who is:
 - (1) in possession of a valid permit to camp or cook in a public place;
 - (2) operating or patronizing a commercial establishment that conducts business on the sidewalk in compliance with local ordinances;
 - (3) participating in or viewing a parade, festival, performance, rally, or similar event;
 - (4) sitting on a chair or bench that is supplied by a public agency or by the abutting private property owner;
 - (5) sitting within a bus stop zone while waiting for public or private transportation; or
- (6) waiting in line for goods, services, or a public event.
- (e) Whoever is found guilty of violating the provisions of this section shall be fined not more than twenty-five dollars (\$25.00) or sentenced to sixty (60) hours of community service as approved by the court. Whoever is found guilty of second and subsequent offenses in violation of this ordinance shall be fined not more than two hundred fifty dollars (\$250.00) and/or sentenced to sixty (60) hours of community service.
- (f)Referral to any available social services may be ordered, at the court's discretion.

WHEREAS, Sec. 1-05 of The Home Rule Charter for a Consolidated Government for Terrebonne Parish states in its pertinent part that "The parish government shall have and exercise such other powers, rights, privileges, immunities, authority and functions not inconsistent with this charter as may be conferred on or granted to a local governmental subdivision by the constitution and general laws of the state, and more specifically, the parish government shall have and it hereby granted the right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs, not denied by this charter, or by general law, or inconsistent with the constitution." And

WHEREAS, Section 1-06 of the Home Rule Charter for Terrebonne Parish Consolidated Government (TPCG) provides that the Parish Government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary requisite or proper for the management of parish affairs, and all other subject matters without exception, subject only to the limitation that the same shall not be inconsistent with the Constitution or expressly denied by general law applicable to the parish; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code; and

WHEREAS, TPCG wishes to amend Sec. 28-82 of the Terrebonne Parish Code to include campgrounds under prohibited uses within the Houma Restoration Overlay District.

SECTION II

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that the following sections of the Code of Ordinances of Terrebonne Parish at Chapter 28, Section 28-82 shall be and are hereby adopted, with strike through to show deletions and underline to show additions:

Sec. 28-82. Supplementary Houma Restoration Overlay District regulations

(k)Prohibited Uses. Except for those already in existence at the effective date of this Section, the following uses shall be prohibited within the Overlay District:

(9) Car Washes Campgrounds

SECTION III

PARK, CITY (AIRBASE) PARK (EXCLUDING THE GYM, POOL, AND FOOTBALL FIELD), JIM BOWIE PARK, MAHLER ST. PARK, PARISH PARK, LEE AVENUE PARK, MAPLE ST. WHEREAS, TPCG finds that is in the best interest of Terrebonne Parish that Recreation District No. 11 return the care, custody, and control of Authement St. Park, City (Airbase) Park (excluding the gym, pool and football field), Jim Bowie Park, Mahler St. Park, Parish Park, Lee Avenue Park, Maple St. Park, Rio Vista Park, and the Adult Softball Complex to TPCG; and

WHEREAS, TPCG and Rec. Dist. 11 intend to enter into the attached Amendment No. 2 to the Intergovernmental Agreement and Lease to remove the aforementioned parks from the properties covered by the agreement; and

AN ORDINANCE TO AMEND CHAPTER 19, ARTICLE II. - PARADES OF THE TERREBONNE PARISH CODE OF ORDINANCES TO RENAME "MARDI GRAS PARADE SAFETY COMMITTEE" TO "TERREBONNE PARISH PARADE COMMITTEE", TO AMEND THE MEMBERSHIP OF AND DESIGNATE CLERICAL SUPPORT FOR SAID COMMITTEE, AND TO PROVIDE FOR RELATED MATTERS.

WHEREAS, Sec. 1-06 of the Home Rule Charter for the Parish of Terrebonne provides that parish government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including, but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary, requisite or proper for the management of parish affairs, and all other subject matter without exception, subject only to the limitation that the same shall not be inconsistent with the constitution or expressly denied by general law applicable to the parish; and

WHEREAS, the Parish Council wishes to amend the Parish Code in order to rename the "Mardi Gras Parade Safety Committee" to the "Terrebonne Parish Parade Committee" in order to include local parade organizations in deliberations regarding parade safety; and

WHEREAS, the Parish Council wishes to amend the membership of the Terrebonne Parish Parade Committee and to designate the Terrebonne Parish Council Clerk's Office as the Secretary for the Committee to provide clerical support regarding its meetings.

SECTION I

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that Chapter 19, Article II. – Parades, Section 19-31 (a) and (e), Section 19-47 (i), Section 19-51 (a), and Section 19-52 (a) be hereby amended as follows (additions in bold and underline, omissions in strikethrough):

Sec. 19-31. Terrebonne Parish Parade Committee

- (a) <u>A Terrebonne Parish Parade Committee is hereby established and shall consist of the following:</u>
 - 1. One member of the Parish Council appointed by the Chairman of the Terrebonne Parish Council to serve as the Chairman of the Committee
 - 2. One member of the Parish Administration appointed by the Parish President to serve as the Vice-Chairman of the Committee
 - 3. The Sheriff of Terrebonne Parish or their designee
 - 4. The Houma Police Chief or their designee
 - 5. The Houma Fire Chief or their designee
 - 6. One member representing the membership of each parade organization
 - a. The organization representatives shall be selected from the memberships of those organizations enumerated in Section 1978(c)(1) and shall be selected in a manner set forth by those organizations.

(No changes for items (b), (c), or (d))

(e) The Terrebonne Parish Council Clerk's Office shall serve as the Secretary for the Committee and provide clerical support regarding its meetings.

Sec. 19-47. Floats.

(No changes for items (a) through (g))

(i) All floats shall, at the direction of the <u>Terrebonne Parish</u> Parade Safety Committee, submit to inspection for the purpose of setting restrictions to the weight of the floats. The purpose of the inspection is not to set "legal" weight limits, but to identify safe and reasonable limits in the interest of public safety. Parade Organizations are responsible for ensuring the safety of their riders and floats. All floats must have clearly posted weight limits in or on the float and may not exceed the maximum weight rating for the float, fully loaded, including passengers. Floats that have not been directed by the <u>Terrebonne Parish</u> Parade Safety Committee to submit to inspection are exempt from the posting requirements set forth in this section.

Sec. 19-51. Attire and characterization.

(a) Maskers on floats, in automobiles, on horseback, or in any other vehicle in the parade and all marching club members shall be decently attired, and no sexually indecent dress or characterization shall be allowed. Costumes and masks shall be approved by the <u>Terrebonne Parish Parade</u> Safety Committee and shall be worn during the entire parade.

Sec. 19-52. Throws.

(a) Generally. All organizations are prohibited from throwing any object from the floats other than beads, doubloons, candy, or other traditionally recognized trinkets, provided however that an organization may throw other food items, if approved by the Chief of Police and/or the Sheriff. The quantity and types of throws shall be approved by the <u>Terrebonne Parish</u> Parade Safety Committee prior to being loaded onto the floats.

WHEREAS, the project will benefit the communities of Terrebonne Parish.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended to reflect the funding of the Hollywood Road Bridge Extension. (**Attachment C**)

SECTION IV

WHEREAS, the Juvenile Detention Department of the Terrebonne Parish Consolidated Government has been approved a grant from the Louisiana Commission on Law Enforcement (LCLE) and Administration on Criminal Justice, Office of Juvenile Justice & Delinquency Prevention, Office of Justice Programs for the Prison Rape Elimination Act (PREA) Funds FY 2022 in the amount of Eleven Thousand Five Hundred sixty-nine dollars (\$11,569) for the Terrebonne Parish Consolidated Government, and

WHEREAS, the Federal Fiscal Year 2022 LCLE will provide grant funding to assist units of governments to carry out activities that enable agencies to achieve PREA compliance through technical assistance and other resources.

NOW, THEREFORE BE IT FURTHER ORDAINED, that the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the Juvenile Detention Department. (**Attachment D**)

SECTION V

WHEREAS, the Parish has been awarded \$58,078 for the Emergency Management Performance Grant Program - 2024 from the State of Louisiana, Governor's Office of Homeland Security and Emergency Preparedness, and

WHEREAS, the dollars will be reimbursement for the operations associated with the Office of Emergency Preparedness including daily duties conducted by the office staff.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget of the Terrebonne Parish Consolidated Government be amended for the Emergency Preparedness Department. (**Attachment E**)

SECTION VI

If any work, clause, phrase, section, or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections, and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION VII

This Ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.
