APRIL 16, 2025

The Chairman, Mr. C. Harding, called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Mr. J. Amedée led the Invocation and the Pledge of Allegiance. Upon roll call, Council Members recorded as present were: J. Amedée, C. K. Champagne, C. Hamner, D. Babin, K. Chauvin, S. Trosclair, B. Pledger, C. Harding, and C. Voisin, Jr. A quorum was declared present.

Mr. B. Pledger requested a moment of silence in remembrance of one of the school's teachers, Mr. Remy Hanemann, who recently passed.

The Chairman recognized Mr. William Simmons, LMTCT Principal, who thanked the Parish for the recognition. He then announced that they will be competing in Atlanta for Nationals, which they will dedicate to Mr. Hanemann.

The Chairman recognized Ms. Meka Johnson, SkillsUSA Louisiana President, who thanked the Parish for the recognition then thanked all the participants for their hard work. She then shared that a welding sculpture competition was created by Mr. Hanemann with thirty participants competing this year, with twelve from Terrebonne Parish.

Several Council Members and Administration congratulated the contestants, parents, and coaches, then wished them luck at Nationals.

The Chairman recognized Dr. Patrick Walker, Terrebonne Parish Coroner, who gave an overview of the Terrebonne Interception and Prevention Services (T.I.P.S.) program and its goal of addressing issues regarding mental health and addiction, especially those connected to accidental drug overdoses. He then briefly reviewed a budget proposal and requested that the Parish support the program.

The Chairman recognized Mr. Richard Warren, Chief Investigator for the Coroner's Office, who shared his support for the program as preventative measures for those at risk of accidental drug overdoses.

Discussion ensued relative to similar programs and the program's procedures for assisting those with addictive conditions and mental health concerns to prevent potential health crises for residents of the parish.

Upon request, Dr. Walker gave an overview of the current procedures and limitations for tracking individuals and providing guidance, materials, and support through the program.

At Ms. K. Chauvin's inquiring, Parish President Jason Bergeon noted that two facilities are being constructed to provide for a 24-hour crisis center at the START Corporation building and for an additional building at the current Health Unit.

Several Council Members shared their support for assisting those residents in need and opportunities for greater cooperation and funding toward addressing mental health and addiction issues in the parish.

- I. Quality of Life-Keep Louisiana Beautiful Initiative, \$9,993
- II. CDBG-DR-Fletcher Aviation Workforce Development, \$5,000,000
- III. Federal Emergency Management Agency-Geraldine Pump Station, \$9,760,659

SECTION I

WHEREAS, Terrebonne Parish Consolidated Government has been awarded funds from the State of Louisiana, Department of Culture, Recreation and Tourism, Keep Louisiana Beautiful Initiative in the amount of \$9,993, and

WHEREAS, the grant will be used for equipment to maintain the parks under the Quality of Life Department.

NOW, THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2025 Adopted Operating Budget be amended for the Keep Louisiana Beautiful Initiative grant. (**Attachment A**)

SECTION II

WHEREAS, Terrebonne Parish Consolidated Government's application for the Fletcher Aviation Workforce Development project has been approved for \$5,000,000, and

WHEREAS, the Louisiana Office of Community Development- Disaster Recovery has approved the funds under the Parish's Resilient Communities Infrastructure Program allocation, and

WHEREAS, these are the funds commonly referred to as CDBG-DR funds.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government that the 2025 Adopted Budget be amended for the CDBG-DR funding for the Fletcher Aviation Workforce Development project. (**Attachment B**)

WHEREAS, the funding will be used for the Resilient Infrastructure Bayou Black project (Geraldine Pump Station).

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2025 Adopted Operating Budget and 5-Year Capital Outlay Budget be amended for the Geraldine Pump Station Project. (**Attachment C**)

SECTION IV

WHEREAS, Terrebonne Parish Consolidated Government's application for the Pump Station at Bayou Black (Geraldine Pump Station) for \$3,500,000 has been approved, and

WHEREAS, the Louisiana Office of Community Development-Disaster Recovery has approved the funds under the Parish's Resilient Communities Infrastructure Program allocation to be used as the local match for the Pump Station at Bayou Black (Geraldine Pump Station), and

WHEREAS, these are the funds commonly referred to as CDBG-DR funds.

NOW, THEREFORE BE IT FURTHER ORDAINED, that the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2025 Adopted Operating Budget be amended for the Pump Station at Bayou Black (Geraldine Pump Station) project. (**Attachment D**)

WHEREAS, Terrebonne Parish Consolidated Government has been awarded \$2,600,000 from the Department of Commerce-Economic Development Administration, and

WHEREAS, the funds were awarded for the Enterprise Drive and Westside Boulevard Corridor Infrastructure Expansion, and

WHEREAS, this is a project being completed in collaboration with Terrebonne General Health Systems and Consolidated Waterworks.

NOW, THEREFORE BE IT FURTHER ORDAINED, that the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2025 Adopted Operating Budget and the 5-Year Capital Outlay Budget be amended for the Enterprise Drive and Westside Boulevard Waterline Expansion project. (**Attachment E**)

SECTION VI

WHEREAS, Administration is requesting to recognize funding for the waterway debris removal from Hurricane Francine, and

WHEREAS, \$1,037,070 is from a grant from the US Department of Agriculture, Natural Resources Conservation Service, and

WHEREAS, the Local Match of \$314,264 is from the Drainage Tax Fund.

NOW, THEREFORE BE IT FURTHER ORDAINED, that the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2025 Adopted Operating Budget and the 5-Year Capital Outlay Budget be amended for the Hurricane Francine waterway debris removal project. (**Attachment F**)

ORDINANCE NO. 9697

AN ORDINANCE RENAMING "BILLY STREET" TO "HAZEL BOYKIN STREET", A PUBLIC PARISH MAINTAINED STREET, AND INCORPORATING SAME INTO THE ENHANCED 911 EMERGENCY RESPONSE SYSTEM FOR THE PURPOSE OF PROVIDING A BETTER MEANS OF LOCATING ADDRESSES; TO SET FORTH AN EFFECTIVE DATE FOR THE INCORPORATION OF STREET NAME, TO INFORM THE PROPER AGENCIES OF THE STREET NAME, AND TO AUTHORIZE THE INSTALLATION OF STREET SIGNS; AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the public Parish maintained street located as follows, and shown on the vicinity plats attached hereto and made part hereof is renamed:

1. "Billy Street" in Houma be renamed to "Hazel Boykin Street", Council District 2

BE IT FURTHER ORDAINED that, effective on the 21st day of April 2025, the aforementioned street shall be incorporated into the Enhanced 911 Emergency Response System; and,

RESOLUTION NO. 25-153

A resolution approving the holding of an election in Fire Protection District No. 9 of the Parish of Terrebonne, State of Louisiana, on Saturday, October 11, 2025, to authorize the continuation of a special tax therein.

WHEREAS, the Board of Commissioners of Fire Protection District No. 9 of the Parish of Terrebonne, State of Louisiana (the "Governing Authority"), acting as the governing authority of Fire Protection District No. 9 of the Parish of Terrebonne, State of Louisiana (the "District"), adopted a resolution on April 1, 2025, calling a special election in the District on Saturday, October 11, 2025, to authorize the continuation of a special tax therein; and

WHEREAS, the Governing Authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of Terrebonne, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to authorize the District to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of Terrebonne, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Fire Protection District No. 9 of the Parish of Terrebonne, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, October I 1, 2025, at which election there will be submitted the following proposition, to-wit:

PROPOSITION (MILLAGE CONTINUATION)

Shall Fire Protection District No. 9 of the Parish of Terrebonne, State of Louisiana (the "District"), continue to levy a 16.46 mills tax (the "Tax") on all property subject to taxation in the District (an estimated \$393,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of 10 years, beginning with the year 2027 and ending with the year 2036, for the purpose of acquiring, constructing, maintaining and operating the District's fire protection facilities, and paying the cost of obtaining water for fire protection purposes, including fire hydrants rentals and service, provided that a portion of the Tax proceeds is required to be contributed to state and statewide retirement systems as provided in R.S. 11:82, said millage to represent a 1.46 mills increase (due to reappraisal) over the 15 mills tax authorized to be levied through the year 2()26 pursuant to an election held on November 8, 2016?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.
