RESOLUTION NO. 25-212

A RESOLUTION OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT APPROVING THE ISSUANCE OF NOT TO EXCEED SIX MILLION DOLLARS (\$6,000,000) IN AGGREGATE PRINCIPAL AMOUNT OF REVENUE BONDS, IN ONE OR MORE SERIES, BY THE HOUMA-TERREBONNE AIRPORT COMMISSION, PARISH OF TERREBONNE, STATE OF LOUISIANA.

WHEREAS, the Board of Commissioners (the "Board") of Houma-Terrebonne Airport Commission, Parish of Terrebonne, State of Louisiana (the "Commission") has adopted a resolution relative to the issuance, sale and delivery of not exceeding Six Million Dollars (\$6,000,000) Revenue Bonds (the "Bonds"), in one or more series, for the purposes of constructing and acquiring improvements, extensions and replacements at the Houma-Terrebonne Airport/Industrial Park (the "Airport"), including, but not limited to, hangars, terminal facility, appurtenant equipment, accessories, and additions to such facilities at the Airport, all works of public improvement and/or revenue-producing projects for the Commission, and to pay costs of issuance of the related financing (collectively, the "Project"); and

WHEREAS, the Parish Council of the Parish of Terrebonne, State of Louisiana (the "**Parish Council**"), acting as the governing authority of the Parish of Terrebonne, State of Louisiana (the "**Parish**"), desires to affirm and ratify the issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish, that:

SECTION 1. The Parish Council hereby consents to and approves of the issuance, by the Commission, of the Bonds for the purposes of the Project.

SECTION 2. The Parish Council's consent and approval is given pursuant to the applicable provisions of Louisiana law relating to the issuance of obligations of subordinate

entities such as the Commission, and such approval should not be construed as expressing any view whatsoever as to the ability of the Commission to make the payments contemplated by the Bonds.

SECTION 3. The Bonds shall not be obligations of the Parish but shall be obligations of the Commission secured by and payable solely from, collectively, the funds, income, revenues, fees, receipts or charges of any nature from any source whatsoever on deposit, with or accruing from time to time to, the Commission, provided that no such funds, income, revenue, fees, receipts or charges shall be so included in this definition which have been or are in the future legally dedicated and required for other purposes by the electorate, by the terms of specific grants, by the terms of particular obligations issued or to be issued (to the extent pledged or budgeted to pay debt service on such other obligations) or by operation of law.

WHEREAS, for the purposes of the development of downtown Houma, the Terrebonne Parish Consolidated Government Administration recommends to the Terrebonne Parish Council that the Parish President, Jason W. Bergeron, be authorized and empowered for and on behalf of the Terrebonne Parish Consolidated Government ("TPCG") to execute documents necessary to lease the Property located at 7842 Main Street, Parcel No. 19175 (the Property) to the TPCG in, which basic terms are described below; and

WHEREAS, the Terrebonne Parish Consolidated Government Administration recommends to the Terrebonne Parish Council to authorize the Terrebonne Parish President, Jason W. Bergeron, to execute a lease of the Property to TPCG from the property owner(s) for approximately eleven (11) months out of the calendar year, for a period of three (3) years, for the base rental sum of \$1,500.00 per month, together with other terms and conditions of the lease approved by the Legal Department, including but not limited to TPCG paying its proportionate property taxes, as defined therein, utilities, maintenance expenses, and a damage deposit, with TPCG providing insurance..

ORDINANCE NO. 9701

AN ORDINANCE TO AMEND ARTICLE 11, CHAPTER 18, OF THE TERREBONNE PARISH CODE, SECTION 18-30 TO PROHIBIT VEHICLES OVER FIFTEEN TONS ON EAST WOODLAWN RANCH ROAD FROM KYNES ROAD TO LA HIGHWAY 56

SECTION 1

WHEREAS, Section 1-06 of the Home Rule Charter for Terrebonne Parish Consolidated Government (TPCG) provides that the Parish Government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary requisite or proper for the management of parish affairs, and all other subject matters without exception, subject only to the limitation that the same shall not be inconsistent with the Constitution or expressly denied by general law applicable to the parish; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code; and

WHEREAS, there have been safety issues regarding large vehicles on East Woodlawn Ranch Road from Kynes Road to Louisiana Highway 56; and

WHEREAS, TPCG wishes to add East Woodlawn Ranch Road from Kynes Road to Louisiana Highway 56 to Article IV, Chapter 18, Section 18-30, the list of roads that prohibit vehicles over fifteen tons.

SECTION 11

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that the following sections of the Code of Ordinances of Terrebonne Parish at Chapter 18, Section 18-30 shall be and are hereby adopted, with underline to show additions:

Sec. 18-30. — Vehicles over fifteen tons prohibited.

(a) No person shall drive or operate a vehicle having a total weight in excess of fifteen (15) tons, without obtaining a permit from the director of public works, or his designee, in accordance with section 18-32 of this Code, on the following named streets or portions of streets:

East Woodlawn Ranch Road from Kynes Road to LA Highway 56

SECTION 111

WHEREAS, Article VII, Section 14 of the Louisiana Constitution further provides that "For a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual; and,

WHEREAS, the Parish President is authorized under Terrebonne Parish Code Section 2-453 to lease out commercial space in the Hancock Whitney Bank Building on behalf of the Terrebonne Parish Consolidated Government ("TPCG"); and

WHEREAS, the Bayou Region Arts Council ("BRAC") is a Louisiana non-profit organization that supports arts access in Terrebonne Parish and surrounding parishes; and

WHEREAS, the BRAC has requested to continue its tenancy in the building to continue, among other services, its work in supporting the arts in Terrebonne Parish and to provide their services as a benefit to Terrebonne Parish in lieu of rent; and

WHEREAS, TPCG Code Section 2-11 requires an ordinance to lease TPCG property and TPCG Code Section 2-453(d) requires approval of the Council for any lease agreements containing special provisions, commitments, and/or obligations beyond the standard agreement; and

WHEREAS, the proposed lease agreement between BRAC and TPCG is attached and contains special provisions beyond the standard agreement in that the proposed lease agreement requires TFAE to provide services in lieu of rent payments; and

WHEREAS, TPCG's standard rental agreement for commercial space in the Hancock Whitney Bank Building is currently set at \$1.7 per sq.ft./month or \$20.40 per sq.ft./year; and

WHEREAS, the BRAC currently occupies Suite 428, an estimated total of 144.28 square feet, and, according to the standard rate, an annual value of \$2,943.31; and

WHEREAS, TPCG wishes to rent Suite 428 to BRAC for services in lieu of rent and finds that entering into this cooperative endeavor agreement will serve a public purpose by allowing the BRAC to continue arts support operations in the location it has operated in for years, and by locating those offices near other government offices; and that this agreement, taken as a whole, is not gratuitous, with TPCG expecting at least the same value to the public in consideration of this agreement; and

NOW THEREFORE BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

The Parish President is authorized to execute, on behalf of the TPCG, a cooperative endeavor agreement with the Bayou Region Arts Council (BRAC) not materially different from the agreement attached to this Ordinance, subject to approval by the TPCG legal department.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be separable.

SECTION III

This ordinance shall become effective upon approval by the parish president or as otherwise provided in Section 2-13 (b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

ORDINANCE NO. 9703

AN ORDINANCE TO ENACT ARTICLE I, CHAPTER 18, OF THE TERREBONNE PARISH CODE, SECTION 18-10 TO CREATE REGULATIONS FOR PRIVATE STREET SIGNAGE

WHEREAS, Section 1-06 of the Home Rule Charter for Terrebonne Parish Consolidated Government (TPCG) provides that the Parish Government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary requisite or proper for the management of parish affairs, and all other subject matters without exception, subject only to the limitation that the same shall not be inconsistent with the Constitution or expressly denied by general law applicable to the parish; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code; and

WHEREAS, Currently, TPCG pays for the installation and maintenance of all required street signage for private roads; and

WHEREAS, TPCG wishes to charge private landowners for the installation of all required street signage; and

WHEREAS, TPCG wishes to allow private landowners to maintain and repair the street signs on their private road.

SECTION I

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that the following sections of the Code of Ordinances of Terrebonne Parish at Chapter 18, Section 18-10 shall be and are hereby enacted:

Sec. 18-10. – Private Street Signage.

- (a) Private landowners in need of required street signage shall provide a deposit of three hundred dollars to TPCG's Public Works Department for the creation and installation of the signage.
- (b) TPCG will install the signage and provide the landowner with the remainder of the deposit, after costs of sign creation and installation has been determined, by check, through U.S. mail.
- (c) Private landowners shall be responsible for the maintenance and repairs of the street signage once it has been installed.

SECTION II

Babin, "THAT, Policy Procedure and Legal Committee introduce an ordinance to amend Article II, Chapter 11, of the Terrebonne Parish Code, Section 11-34 to provide an increase in disposal charges, amended so that Section 11-34, Subsection B is corrected with the written numerical amounts for disposal fees from \$325.00 to \$350.00 and from \$350.00 to \$375.00 prior to introducing this ordinance to the Council and to call a public hearing on Wednesday, May 28, 2025, at 6:30 p.m." (**MOTION ADOPTED AFTER DISCUSSION)

At the request of Mr. C. Harding, Solid, Hazardous, and Recycling Waste Director Clay Naquin shared that there are currently no fees for commercial recycling in the parish with many big box stores being required to recycle. He then explained that the disposal fees were increased to recapture building and employee expenses and that out-of-parish businesses would use the higher fees. He clarified that the disposing from the green recycling bins throughout the parish is included in the budget then shared that schools would like to begin recycling programs, but the parish cannot afford to do so.

- Mr. C. Harding shared his concerns regarding the parish's ability to provide recycling programs and noted that the fee changes would not impact everyday citizens of the parish.
- Mr. S. Trosclair shared his understanding that recycling is costing parish money derived from taxes and noted his concerns about increasing recycling costs, contaminated recycling bins ultimately being treated as regular disposal, and assurances that the recycled waste is being recycled appropriately.

The Chairman recognized Parish President Jason Bergeron who shared that about 80% of material placed in recycling bins is not recycled due to contamination, but all the recyclable material is being recycled and converted to methane, natural gas, and other resources.

Ms. K. Chauvin suggested that the recycling program should be suspended until a more feasible recycling plan could be established.

Discussion ensued relative to the continuation of a recycling program and educating residents within the parish regarding recyclable materials and potential contamination.
